New Jersey continues to make a commitment to provide financial assistance to eligible foster, adoptive, and homeless youth seeking a post-secondary education. Through the New Jersey Foster Care Scholars Program, educational funding has been made available to help youth make a successful transition to adulthood and self-sufficiency.

This program is made possible by the passage of N.J.S.A. 30:4C-101 et seq., (*Tuition Waiver Bill*) and the John Chafee Foster Care Independence Program through the Educational Training Voucher (ETV) initiative. This scholarship is dedicated to the memory of Claudette Haba. Ms. Haba was an artist who worked hard to improve the foster care system in New Jersey. She was working for the New Jersey Division of Youth and Family Services (DYFS) when she unexpectedly passed away in December 1999 at the age of 51.

New Jersey Foster Care Scholars (NJFC) is funded by State and Federal dollars. Youth may be eligible to receive assistance with the following:



Since the scholarship has two sources of funding each has its own eligibility criteria. Your personal status will determine which source of funding will fund your scholarship and what services your scholarship will pay for. Some applicants will be limited to attending in-state public schools, full time, and their scholarship will only pay for their tuition and fees.

THE NEW JERSEY FOSTER CARE SCHOLARS PROGRAM

The New Jersey Foster Care Scholars Program is intended to assist current and former foster youth in their pursuit of higher education. Some adopted youth and homeless youth living in transitional living programs may also be eligible to receive awards. Each application is processed on a case by case basis.

Use this page to help determine if you should apply for the New Jersey Foster Care Scholars Program. **Please use this page as a guide only.** Final eligibility is determined by the Department of Children and Families. ***Please note it may take up to 3-5 weeks for applications to process.**

If you have any questions, please refer to the frequently asked questions on the back (page 6) of this booklet, or call Foster and Adoptive Family Services (FAFS) at 800/222-0047 and ask to speak with a scholarship representative.

HOW DO I KNOW IF I AM ELIGIBLE TO APPLY FOR THE NJFC SCHOLARS PROGRAM?

Applicants must meet **all** of the following requirements:

- Be between the ages of 16 and 22;
- Be in possession of a high school diploma or certificate of high school equivalency (GED) ***(High school seniors may apply before receiving their diploma, but scholarship award is contingent upon graduation.)***
- Be accepted in or granted admission to a degree or certificate granting post-secondary institution that has been accredited to receive Title IV funding (Federal Financial Aid) ***(If you are unsure whether or not your school meets this criteria you may call us at 800.222.0047);*** and
- Have completed the Free Application for Federal Student Aid (FAFSA)
- Have made an application for Educational Opportunity Fund (EOF) if attending a NJ school that offers this program. A list of schools may be found by going to http://www.state.nj.us/highereducation/EOF/EOF_programs.htm
- Have a working e-mail address (New students will be emailed as part of the application process in order to verify.)

In addition, applicants must meet at least **ONE** of the following:

Youth who are or were in a DYFS paid placement:

- Have you been in the care and custody of DYFS, in an out of home placement, **for a period of 9 months or more following your 16th birthday?**
- Are you, or have you been, in the care and custody of DYFS, in an out of home placement **after your 14th birthday for a total of 18 months?**
- Do you reside in, or have you resided in a Transitional Living Program for youth or supportive housing **for 3 months or more?**
The facility or program must receive payment pursuant to the New Jersey Homeless Youth Act or the Federal Runaway and Homeless Youth Act.

Adopted Youth:

- Were you adopted through the New Jersey Division of Youth and Family Services **after the age of 12 and currently in a subsidized adoption? (Subsidy must be in place at time of application.)**
- Were you adopted through the New Jersey Division of Youth and Family Services **after the age of 16?**

Kinship Legal Guardianship (KLG): **KLG is when the court grants the caregiver legal responsibility for the youth, and the caregiver has the rights of care, custody and supervision of the youth.**

- Did you leave an out of home paid placement through the New Jersey Division of Youth and Family Services to enter Kinship Legal Guardianship **after the age of 16?**

When Can I Apply?

Each academic year a new scholarship application is made available (usually April or May)

Complete applications with all documents will be accepted until:
October 1st 2010 for the Fall semester
March 1st 2011 for the Spring semester

The NJFC Scholars Program recommends that students submit this application and all applications as early as possible.

If you have questions about the deadlines contact the Scholarship Department at the number below.

PARTICIPATION AGREEMENT:

This is an agreement that all NJFC Scholars recipients must sign and return to FAFS before funding will be awarded. The form will be emailed to you and must be returned within 15 business days. If you have any questions once you receive this form please contact the scholarship department.

FUNDING BENEFITS:

Based on the criteria that make you eligible for the NJFC Scholarship money, the staff at FAFS will discuss what benefits you can receive.

<p>Project MYSELF</p> <p>Description: Project MYSELF (Mentoring Youth toward Social, Educational, and Life Fulfillment) is a multi-service program for former and current foster youth as they pursue post-secondary educational opportunities. Project MYSELF participants are automatically enrolled into Project MYSELF upon receiving financial assistance from the New Jersey Foster Care Scholars Program (NJFC). Through a partnership with Transitions for Youth's Project MYSELF hosted by the Rutgers School of Social Work, DYFS and NJFC, young adults aging-out of the child welfare system also receive the mentorship, support, guidance, referrals and encouragement needed to stay in and succeed in school. Each Project MYSELF participant is assigned a support coach, who is available to help youth with issues related to academic functioning, emotional resiliency, physical wellness, and community, peer and adult partnerships.</p> <p>The program is designed to (1) improve academic performance, (2) increase retention rates, (3) complete post-secondary education degrees, and (4) offer opportunities to develop essential life skills and competencies to live and succeed independently.</p> <p>PM services include (1) support coaching, (2) assessment and referrals, (3) e-mentoring and tele-mentoring, (4) crisis intervention, (5) emotional resiliency skill-building groups in the New Brunswick office, (6) monthly outreach in the form of a newsletter and (7) social networking site (Facebook) which highlights information related to PM events, meetings, resources and information on relevant topics around positive youth development and improving their academic functioning. On this page you will find three waiver forms. APPLYING FOR NJFC Scholars Program:

Who can I contact if I need help filling out my application?

Contact Foster and Adoptive Family Services at 800/222-0047 or send an email to scholarships@fafsonline.org.

What is The Free Application for Federal Student Aid (FAFSA)?

The FAFSA is a form produced by the Federal Department of Education which allows you to apply for all federally funded student aid. Applications can be obtained at <http://www.fafsa.ed.gov> or by calling the FAFSA hotline at 1-800-4-FED-AID.

What is acceptable proof that I filled out my FAFSA?

For the NJFC application, it is required that you submit proof of a completed, current FAFSA. This proof may be in the form of a Student Aid Report (SAR) or printed confirmation page from the FAFSA website (<http://www.fafsa.ed.gov>).

What is the Educational Opportunity Fund (EOF) Program?

The EOF program was created to ensure meaningful access to higher education for those who come from backgrounds of economic and educational disadvantage. To ensure the opportunity to attend college, EOF provides supplemental financial aid to help cover college costs and hosts an array of campus based outreach and supportive services at 28 public and 13 independent institutions. For more information or to find out if your school participates you may go to (<http://www.state.nj.us/highereducation/EOF>).

What will happen if my application packet is INCOMPLETE?

If the information received in your packet is incomplete, a NJFC staff member will call or send an email and you will have fifteen (15) business days from the receipt of the packet to provide the missing information. If your packet remains incomplete after fifteen (15) business days, your application may be denied for the current funding cycle.

What will happen if my application packet is COMPLETE?

Completed applications are usually processed in 3 to 5 weeks. If you are accepted into the NJFC Scholars Program, you will be emailed a [participation agreement](#). This must be printed, read, signed and returned to the staff of the NJFC Scholars Program within (15) business days of sent email. You will also receive a welcome packet detailing how to access your scholarship, and reminding you about the [participation agreement](#). The letter will include the business card of your scholarship support representative, who can help guide you and answer any questions. If the [participation agreement](#) is not completed and returned, you will not receive any funding.

If my application is denied, can I re-apply?

Yes. If you were not eligible when you applied or if you did not submit a complete information packet.

What is considered a DYFS paid placement?

- Resource Family (foster parent)
- Group Homes
- Residential Treatment Centers
- Independent Living Facilities

ONCE ACCEPTED INTO NJFC Scholars Program:

Do I have to re-apply every year?

Yes. You must re-apply every year for the NJFC Scholars Program. The staff of Foster and Adoptive Family Services will send scholarship recipients a new application each year, usually via email. The application must be filled out and returned with the required supplemental materials.

Once accepted, how do I get help with tuition?

Keep Foster and Adoptive Family Services informed! Call us at 800/222-0047 after you have registered for classes. Foster and Adoptive Family Services will contact your post-secondary institution to determine how much additional funding you will need for tuition and associated fees. Your award will be sent directly to your post-secondary institution. Tuition and fees are always our first priority, followed by other school charges. No other funding will be awarded until school bills have been processed.

Once accepted, how long will it take to get my award?

Award disbursement dates vary. We recommend that students who are accepted into the program register at their post-secondary institution as early as possible. Students should keep their school informed they are a part of the NJFC Scholars Program. Registering for classes early and informing your school's Student Accounting/Bursar's Office that you will be receiving our scholarship will help to speed up the award disbursement process.

In the tuition and fees that are paid first, what is considered a fee?

The fees that are included here are automatically added on to students' bill when they register for classes. Fees may include lab fees for science classes, recreational fees at the school, computer lab fees or medical insurance fees. If students have another form of health insurance, such as the Medicaid Extension for Young Adults (MEYA), they should contact their school and ask if the medical insurance fee can be removed.

It is important to note that dorm or meal plan costs are not included in these initial fees. These items fall under additional supports.

Once accepted, how do I get help with other educational expenses (rent, computer, books, transportation, etc)?

To obtain educational supports other than tuition, send to Foster and Adoptive Family Services a completed Educational Support Request form (ESR). These special forms are available on our website or by calling 800/222-0047. The total amount provided will be determined on a case-by-case basis and may not exceed the lesser of \$5,000 or your cost of attendance. A student's tuition need will be taken into account before providing any other educational supports. Fax requests to 609-452-2635 (alternate fax number: 609-520-1515) or email completed forms to scholarships@fafsonline.org. **NOTE: Checks take 4 to 6 weeks to process and are not routinely sent to students. Requests must be made as early as possible. Your request may be denied due to funding availability and/or eligibility.**

Can I use the NJFC Scholars Program at ANY school?

No. The school you attend must be able to accept Federal Title IV funding. An easy way to see if your school or program takes this Title IV funding is to ask at the financial aid department or check <http://www.students.gov>. Schools and programs that accept Federal Title IV funds have an assigned school code, which can be found on the federal website. Alternatively, you may call 800/222-0047 and ask a scholarship representative.

Do I have to contact someone to register for Project MYSELF?

No. Once you are accepted into the New Jersey Foster Care Scholars Program your information will be given to the Project MYSELF Program and they will contact you in reference to your role in the program and its requirements.

Do I have to participate in Project MYSELF?

Yes. All students accepted into the New Jersey Foster Care Scholars Program are required to participate in the Project MYSELF mentoring program.

What are my responsibilities as an NJFC Scholar?

- You must have a working e-mail address and stay in contact with FAFS and Project Myself on a monthly basis.
- You must sign the [participation agreement](#), which will be sent to you upon your acceptance and adhere to the requirements listed in that document.
- You must maintain a 2.0 Grade Point Average (GPA), pass all remedial classes, and make forward academic progress every semester.
